

BAIC South Africa – Festival of Motoring Ticket Giveaway Terms & Conditions

1. Promoter

This promotional competition is organised by **BAIC South Africa** ("the Promoter").

2. Eligibility

2.1. The competition is open to legal residents of South Africa who are **18 years of age or older**.

2.2. Employees of BAIC South Africa, its associated companies, agencies, suppliers, and their immediate family members are not eligible to enter.

2.3. To enter, participants must:

- Follow BAIC South Africa's official social media page on the platform they are entering from.
- Tag at least one friend in the comments of the competition post.
